Chapter 4: Preparing for the Test Session ARRL VE Exam Maker Software Phased Out

ExamTools Online Exams System Replaces ARRL VE Exam Maker Software

ARRL VEC's Exam Maker test generating software is no longer supported as of December 2020. Adobe Flash player was discontinued which is our software's installation platform. The Exam Maker program should no longer be used even though the program may continue to function. We will not be able to push out any important updates to the software, question pools, or questions.

We are urging our VEs to use the **ExamTools** online exams program which is a more sophisticated computer system. The system works well for **online or printed examinations** and includes registering and tracking candidates throughout the session, on screen exams and grading, online signing of CSCE and 605 forms by the candidate and examiners, logging and compiling session stats and VE participation list (test report summary), and output files for upload to the coordinating VEC. The program manages/handles almost everything needed to conduct a test session. See the **ExamTools instructions** in the Video-supervised Online Exams section to get started. These instructions are also available on the <u>VE Resources</u> page.

<u>Video-supervised Online Exams</u>

VE teams are using the online exams for remote video-supervised testing and at in-person sessions.

The remote video exam session is conducted using an online video conferencing platform and a web-based examination system with on-screen tests. VE teams are using the **ExamTools** online exams for the remote video sessions. The system also works well for in-person sessions.

For teams that do not need the remote video sessions information, just follow the online exams and in-person session instructions for using online or printed exams at in-person sessions.

ExamTools printed exams have the option to use the GradeCam program for grading tests or our grading templates. GradeCam will automatically grade exams in seconds using the camera on a phone or computer, which eliminates the need to manually score the tests. Our blue overlay grading template designs are loaded into the program and can be used with the ExamTools printed exams for manual grading of the tests.

<u>Instructions for conducting remote video-supervised exam sessions and using ExamTools online exams</u> [updated 08/13/2021]

ARRL VE teams must meet the following criteria and adhere to the following rules/policies to participate in the video sessions program. Long-standing, well established teams with a history of adhering to the highest degree of examination integrity, and that consistently submit accurate exam documents in compliance with ARRL VEC standards will be selected to participate.

Time and experience with in-person exam sessions is invaluable when transitioning to video sessions. Team leader experience at in-person sessions and/or training with an established team as a team leader for video sessions is required.

Online Exams

VE Teams are using the <u>ExamTools</u> website for online examinations. The system works well for **online or printed examinations** and includes registering and tracking candidates throughout the session, on screen exams and grading, online signing of CSCE and 605 forms by the candidate and examiners, logging and compiling session stats and VE participation list (test report summary), and output files for upload to the coordinating VEC. The program manages/handles almost everything needed to conduct a test session.

- 1. Watch the ExamTools training video playlist.
- Read <u>all</u> the information in the <u>ExamTools Overview</u>. In the <u>Volunteer Examiners</u> section learn how to <u>register for an account</u>. Other helpful information is located in the <u>ExamTools documentation</u> site. To activate the account, you must upload an <u>official</u> copy of your FCC license under your account settings. It's a quick process and takes only about 30 seconds as long as you upload the official license. Reference copies are not accepted.
- 3. Register in the sandbox/development site at http://hamstudy.dev/ and then login at https://beta.examtools.dev/ with your team members. DO NOT use a Facebook or Google login: Make a "real" user. The sandbox/development site is used for any training purposes and runs on its own database to avoid any issues with the ExamTools production environment.
- 4. Join the VE Discord discussion group at https://discord.gg/CsKrBmA where you'll find a lot of useful information including how to register for ExamTools.org as a VE and how to upgrade your VE Discord membership access.
- 5. **Join an existing ARRL VE team as a VE for a live training session**. Volunteer in the **#arrl** Discord channel so you can see the real system in action.
- 6. **ARRL VE team leaders**: Review the <u>ARRL VEC ExamTools FAQ</u> and <u>ExamTools Team Lead Instructions</u>. ARRL team leaders (liaisons) must receive an authorization email from the VEC granting permission to run exam sessions in ExamTools. Email <u>VEC@arrl.org</u> or <u>msomma@arrl.org</u> for approval.

Video-supervised Session

We found that when very detailed instructions and procedures are given to candidates ahead of the sessions, it resulted in smoother sessions for everyone with less technical issues. We urge you to follow this guideline. An example has been provided from one of the teams currently conducting video-supervised sessions.

You may use their wording (or similar text) when setting up video testing in your area.

Zoom is currently the most common video conferencing platform being used, but others can be utilized (such as Microsoft Teams, GoToMeeting, BigBlueButton, Discord, etc.) if the team is more familiar with those systems.

The team will need to set up a way to electronically accept test fee payments directly (such as Paypal, Venmo, Zelle, Apple Pay, Google Pay, etc.) and then the team will have to send the VEC a check or pay for the candidates with a credit card.

We suggest beta testing your entire process with team members, family members, or known candidates (such as students from your club's ham radio classes) before offering video exams in your community or to a wider audience.

E-File Session Documents Web Page

When the team is ready to go, we can set you up with access to our private and secure upload page for the session files and add your team to the list of available remote testing teams. The ExamTools system automatically creates two files (one PDF and one JSON) for easy upload by the team. Our upload page will display an on-screen acknowledgement of receipt of the upload or a failure message when unsuccessful.

ExamTools VE teams must upload one (1) session PDF file and (1) JSON file at the same time. Please keep the JSON and PDF file names the same as what ExamTools names them. Again, **please do NOT change the names of these files**. The output session PDF file will include the following forms: ExamTools Session/VE Manifest (which is the Test Report/Candidate Roster), 605s, Examinations/Exam Answer Sheets, and CSCEs.

In-person Sessions and Printed Exams Information

ExamTools **online** exams can also be used at in-person sessions. View the <u>in-person sessions exam process</u> instructions. The program will also create **printed** exams that utilize **GradeCam for grading tests**. GradeCam will automatically grade exams in seconds using the camera on a phone or computer, which eliminates the need to manually score the tests. Our blue overlay grading template designs are loaded into the program. Therefore, they can be used with the ExamTools printed exams. **Follow the instructions above for creating an account and becoming an ExamTools Team Lead (#6). Read the <u>printed exam creation</u> instructions for more information and how to use the printed exams with the ARRL VEC <u>blue grading templates</u>. For teams that plan only to print the exams and will not be utilizing ExamTools during sessions, only the VE team leader will have to create an account. Teams can e-file session documents using our secure upload page. Contact the VEC department for instructions.**

Chapter 5: FORM 605

Supplemental Information for VEs and Applicants Completing the NCVEC 605 Form

Basic Qualification Question Instructions (Felony Question), FRN, and Email

All exam applicants must provide an FRN and email address and must answer the Basic Qualification Question on the NCVEC 605 Form at the exam session.

Each applicant for a new license or license upgrade and three ARRL VEC accredited Volunteer Examiners must complete NCVEC QUICK-FORM 605 APPLICATION 2022 at ARRL VEC coordinated exam sessions. All NCVEC 605 Form versions issued prior to September 2017 are obsolete and cannot be used. Here are step by step instructions for completing the NCVEC 605 Form.

FCC Registration Numbers (FRN): Exam Candidates are REQUIRED to register in the FCC CORES registration system and receive an FCC Registration Number (FRN) <u>before</u> exam day. Candidates can go directly to the FCC CORES User Account and Registration page: https://apps.fcc.gov/cores/userLogin.do. Click <u>Here</u> for FCC CORES Tutorial Videos.

Email Address: A valid email address is mandatory on the application form. On December 30, 2020, the FCC Wireless Services ceased the printing of paper licenses. The FCC will now only provide these documents electronically through email.

Basic Qualification Question: Applicants are required to answer the FCC basic qualification question. Applicants that answer "YES" to the basic qualification question must submit the required documentation directly to the FCC. Instruct candidates to follow the FCC instructions and procedures and reference the application file number. The candidate must take action within 14 days of the application filing date, or the application will be dismissed by the FCC. The candidate should not communicate any information or documents to the VE team or the VEC. Candidates should be aware that some information about them will be made publicly available on the FCC's website: FCC Licensee Privacy

All ARRL exam session forms can be viewed, downloaded, or printed from the <u>VE Resources</u> page, except the CSCE (Certificate of Successful Completion of Examination) form.

Chapter 6: Conducting the Session

<u>Determine if any Applicant Requires Special Assistance / Procedures for Testing the Disabled:</u> Additional Information.

Minor children (under the age of 18) may be accompanied in the room by an adult during the test.

Accommodations should be made for individuals with special needs such as ADD, ADHD, NLD (Non-Verbal Learning Disorder), and ASD (Autism Spectrum Disorder). The individual should be allowed to have an accompanying support person present or therapeutic support animal that is trained to recognize the needs of the individual in the case of stress or anxiety. Additional accommodations may need to be considered including sound blocking devices for individuals with sound sensitivity, private rooms or rooms of smaller groups, awareness of any tactile sensitivity, etc.

The exam session environment should be calm, respectful, and accommodating to youth and individuals with special needs or other medical conditions and be welcoming to all.

<u>Candidates with Expired Licenses: Additional Information</u> **Expired License Credit is Available**

Partial credit for expired licenses is available provided the ex-licensee successfully passes a new Technician exam.

The FCC does not reinstate or renew the expired license, but they do offer partial credit for expired General, Advanced, and Extra licenses and Technician licenses issued before March 21,1987.

The ex-licensee will not automatically qualify for any new license. At a minimum, previous license holders must pass the current 35-question Technician exam at a VE exam session to return to amateur radio. Depending on the previous license class, the FCC will give partial examination element credit for the higher-level exam(s). The FCC will issue a new license and new sequentially issued call sign to the ex-licensee.

Expired Novice and Tech Plus licenses and Technician licenses issued after March 21, 1987, do not receive any credit.

Chapter 7: Session Report and Returning Documents

Upload the completed session documents for quicker service. Successful new and upgraded license applications are transmitted to the FCC within 1 to 2 business days (for weekend sessions) and are usually transmitted on the same day for weekday sessions.

Session Documents Upload Webpage

Upload in-person or remote session documents via the ARRL VEC's secure session upload webpage. Sessions are processed to the FCC within 1 to 2 business days instead of relying on the postal service to deliver the test package.

Uploading completed sessions as a PDF file (scanned documents) via the web allows for quicker processing to the FCC. Please contact the <u>VEC</u> department (<u>VEC@arrl.org</u>) for the information on e-filing exam session documents through our secure upload page. Authorized VEs will be sent the upload page URL which is hidden from the public.

An FCC Registration Number (FRN) is mandatory. The VE team must only accept FRNs at the session. Social Security Numbers (SSN) are not permitted on any exam documents or session files that are uploaded per the FCC. Candidates will have to be registered in the FCC system and have FRNs already issued. New license applicants must create an FCC user account and register their SSN in the FCC Commission Registration System (CORES) before attending exam sessions.

For in-person sessions using paper exams, the team must include a note or a printout of the upload confirmation page inside the mailed session package stating the date the session was electronically submitted to the VEC.

ExamTools VE teams must upload one (1) session PDF file and (1) JSON file at the same time. Please keep the JSON and PDF file names the same as what ExamTools names them. These sessions do not have to be mailed to the VEC.

\$35 FCC Application Fee

The FCC released a <u>Public Notice</u> on March 23, 2022, stating that the amateur radio application fees, including those associated with Form 605 application filings, are **effective April 19, 2022**. The Federal Communications Commission's authority to impose and collect fees is mandated by Congress.

The \$35 application fee applies to new, renewal, rule waiver, and modification applications that request a new vanity call sign. The fee is per application.

Administrative updates, such as a change of name, mailing or email address, and modification applications to upgrade an amateur radio licensee's operator class or to request a sequentially issued call sign, are exempt from fees.

VECs and Volunteer Examiner (VE) teams should <u>not</u> collect the \$35 fee at exam sessions. The FCC fee must be paid online directly to the FCC not to the VE team or organization processing the application form. VEC and VE team licensing procedures are unchanged. New applicants will pay the \$15 exam session fee to the ARRL VE team as usual, and pay the \$35 application fee directly to the FCC by using the CORES FRN Registration system (https://apps.fcc.gov/cores/userLogin.do).
